The mayor also stated that himself, Mr. Daniels, and people from Alta Fiber had just meet over this exact topic and they insured that they are there for the long term and everything would be put back per specifications. Mr. Clifton also wanted to know about the cleanup that was suppose to happen on South Broadway. Again, the Mayor informed Mr. Clifton that as soon as all legalities were taken care of, we would be moving forward on getting the area cleaned up.
