### **New Business**

#### Department Reports

Solicitor – nothing to report tonight.

<u>BPA</u> – Matt Johnson, Supervisor of the Wastewater Treatment Facility. He wanted to discuss the proposed Sewer Rate increase ordinance. Mr. Johnson went over some of the projects and costs those projects may have. Many projects need to be completed at this time. He wanted to be sure everyone understands, this is just not a maintenance issue, but an issue as to where we now need to replace a lot of equipment. It was agreed upon to go for just 4% at this time and then see what, if anything they would need next year.

PARKS - Gymnasium is now all complete, The next event will be the party in the park which will be 5/24/24 @ 5:00. Band will play from 6-10. They will have food trucks, bands, bounce houses.

Police - Chief Houghton discussed hosting the chiefs meeting this week and the active aggressor training that will take place this August at the school. They had cones with cops today. It was another great success. The computer installs started in the Tahoe's this week.

Street Dept. - Paul Daniels reported that they had touch a truck day, and it was a success. Let everyone know that the water and street departments are starting the Baldwin resurfacing project. This will be a new water main from North Columbus to North Wright, and repaving through North Columbus to North Broadway. Orchard View project will start within the next couple of weeks.

**Zoning** – Jeff Hurst reported Elite Fire Services will be coming to town. They will just be warehousing fire supplies, not a retail store. He also let us know that Red Zone had indeed been annexed into the village in 1986. BP Is suppose to be opening the 1st of June.

Fiscal Officer - Regina Johnson reported that we had two CD's mature at FNB, those were renewed at FNB for 4.75% for 9 months. We did renew a \$200K at Peoples for a much better rate than what it had. We locked it in a 5.3%. Update from Perry and Associates is that we were extended again until July. Fiscal Officer also had asked that Council please refrain from calling Perry and Assoc. for updates as there were things that were missed when one particular councilmember did this.

Mayor - The mayor asked all councilmembers to have anything they would like to discuss to him by the Friday at noon preceeding the meeting, thus allowing us time to prepare.

It was moved by Mr. Hopkins and seconded by Mr. Gephart that the meeting be adjourned at 8:08 pm.
