He is suggesting with the new income tax for the Police Dept. the general fund will have an additional \$500,000 and he would like to see that money spent on giving the Police Department \$100,000, spend \$100,000 to hire a Village Administrator. Would like to see the village allocate \$50,000 for a new Zoning Officer, \$50,000 for a Safety Director, \$50,000 to repair sidewalks, and that all interest received be given to the BPA.
